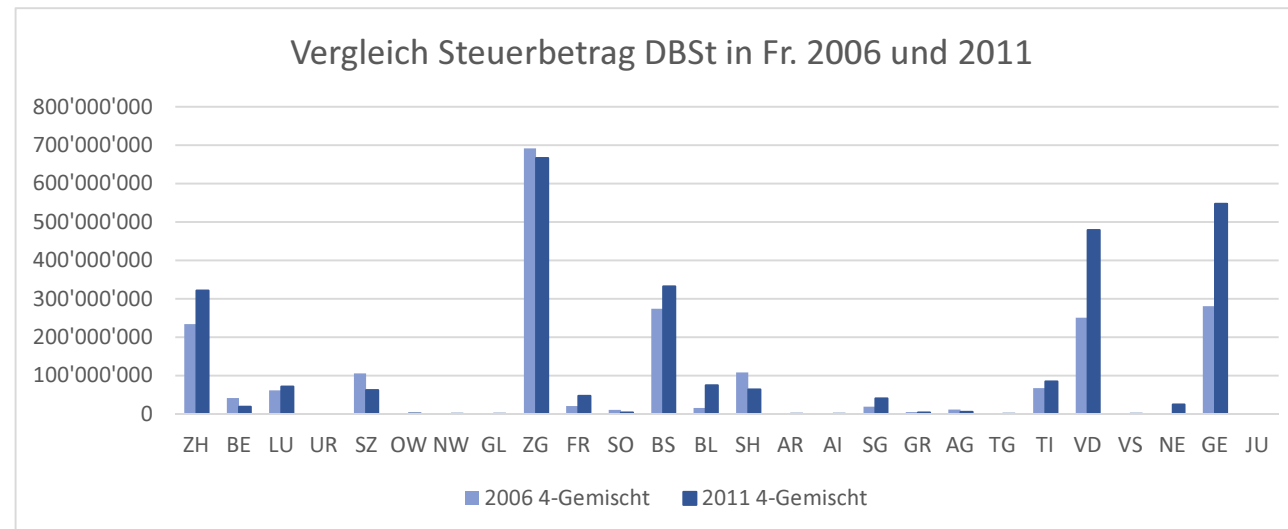
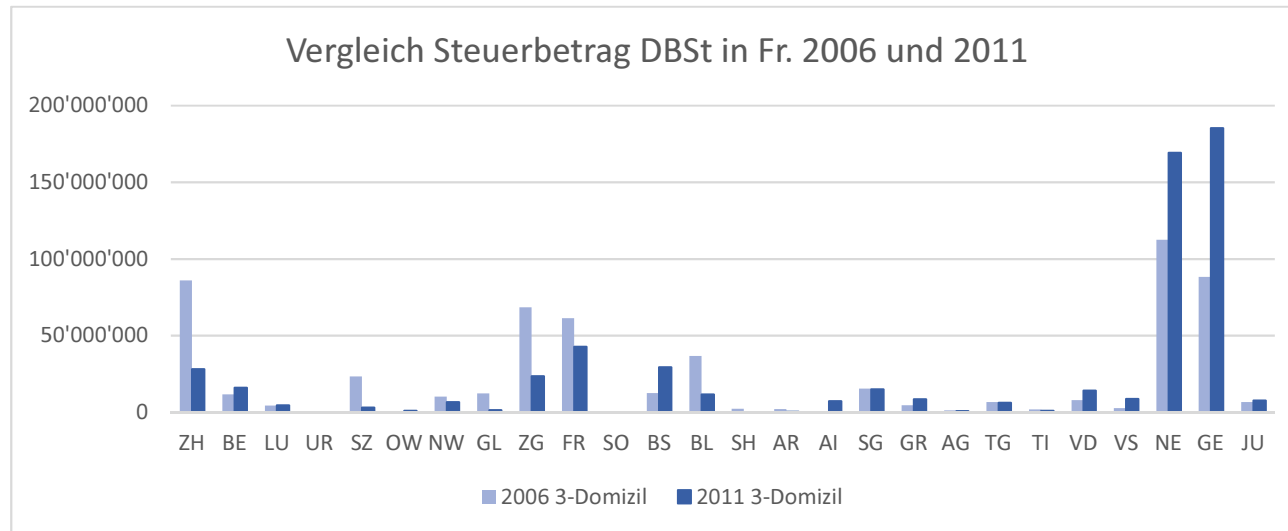
Anhang 4.7 Steuerbeträge der juristischen Personen nach Kantonen 2006 und 2011

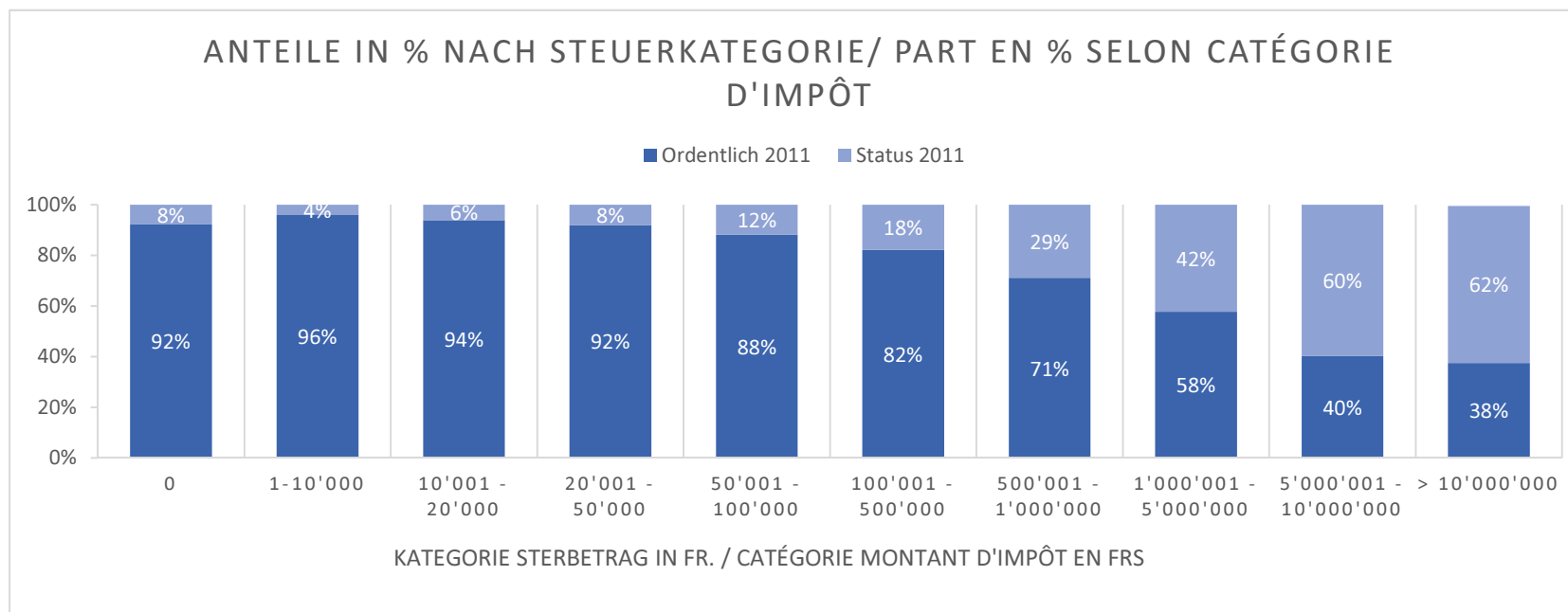


Anhang 4.9 Reingewinne DBSt (abzüglich Nettoerträge aus Beteiligungen) nach Kantonen 2006 und 2011



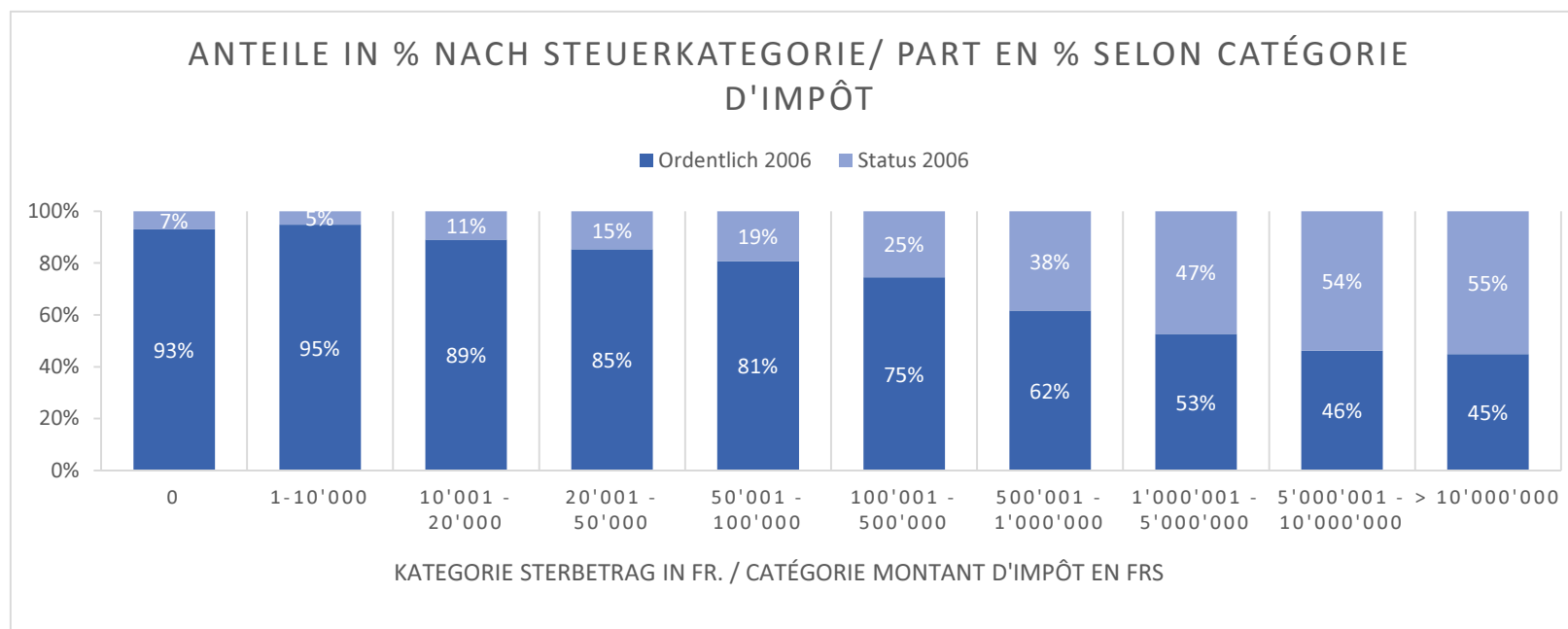

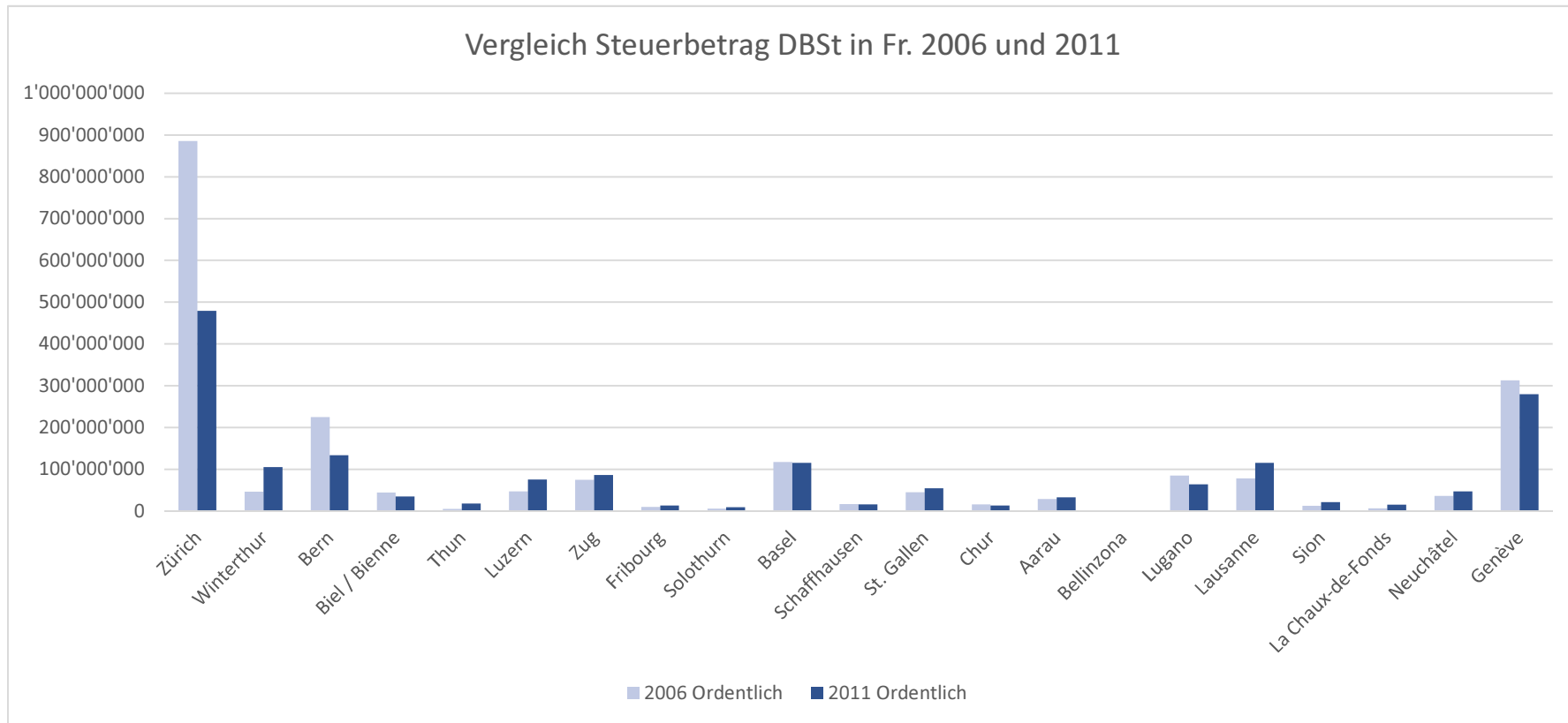

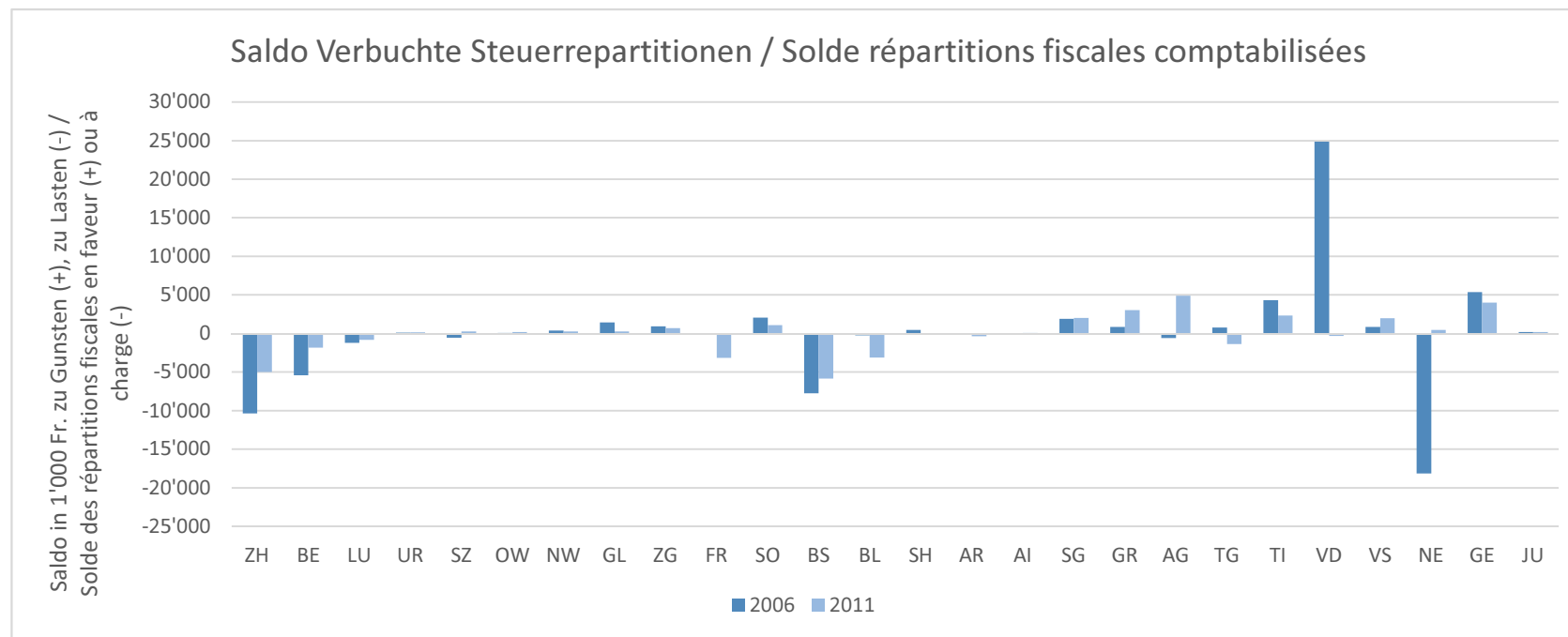


Anhang 4.16 Steuerbeträge der juristischen Personen nach Städten 2006 und 2011
